Kids Activity World Coronavirus / Covid-19 Agreement

Dear Parent

We are excited to be opening and seeing you once again. Due to COVID-19 we have had to put in several safety measures as outlined in this COVID-19 agreement, this in addition to our normal terms and conditions set out in the parent handbook.

Please sign and return if you agree to the following conditions which will allow Kids Activity World to offer a place for your child/children in Summer Holiday Club 2020.

I acknowledge the contagious nature of Coronavirus and that the latest government guidance recommends practising social distancing and a range of other protective measures. Children are advised to socially distance, but they cannot be expected to remain 2m apart.

I recognise that Kids Activity World has put in place a series of protective measures to reduce the risk of Coronavirus transmission within the setting, but I accept that Kids Activity World cannot guarantee that children will not be exposed to Coronavirus whilst attending the club.

I understand that I must follow the procedures and policy set out by Kids Activity World which includes dropping off and collecting my child from the setting

- Queue at the main pedestrian gate off School Lane, using the recommended 2 metre social distancing. (using the preschool buzzer) or call us on 07729766005.
- To queue and social distance on the top playground. Parents can no longer enter the reception area and access to club.
- Opening times are 8:00 17:00 and all children must be collected by 17:00.
- Provide a Packed Lunch
- Apply Sun Cream before attending club.
- Unattended sessions and cancellations within 48hrs will incur a charge. At the owner's discretion, this may be waived.
- You must provide an updated contact number for our records so that we can always contact you on during club hours.
- Kids Activity World may close without notice due to staff shortages or being ordered to by the local health authority, test & trace, or similar government agency.

I understand the importance of vigilance regarding Coronavirus symptoms as a keystone of preventing the transmission of the virus to other children, staff and parents. Accordingly, I confirm that:

- My child is not experiencing any Coronavirus symptoms such as cough, shortness of breath or difficulty breathing, temperature, or new loss of taste or smell.
- Not had paracetamol before entering club that day.
- My child has not tested positive for Coronavirus in the last 7 days or been advised by NHS Test & Trace to self-isolate.
- No one in my child's household or social bubble has Coronavirus symptoms or has been advised by NHS Test & Trace to self-isolate.

- My child has not travelled abroad to any country other than those identified as 'safe' by the government within the last 14 days.
- My child is capable of following the club rules relating to protective measures, such
 as not mixing with children in other bubbles, washing their hands regularly, coughing
 and sneezing into a tissue and disposing of it safely, and not touching other children.
 I understand that if they are unwilling to follow the rules they may not be allowed to
 attend future sessions.

If any of the above circumstances change, I will not bring my child in to the club and will notify the club staff immediately.
